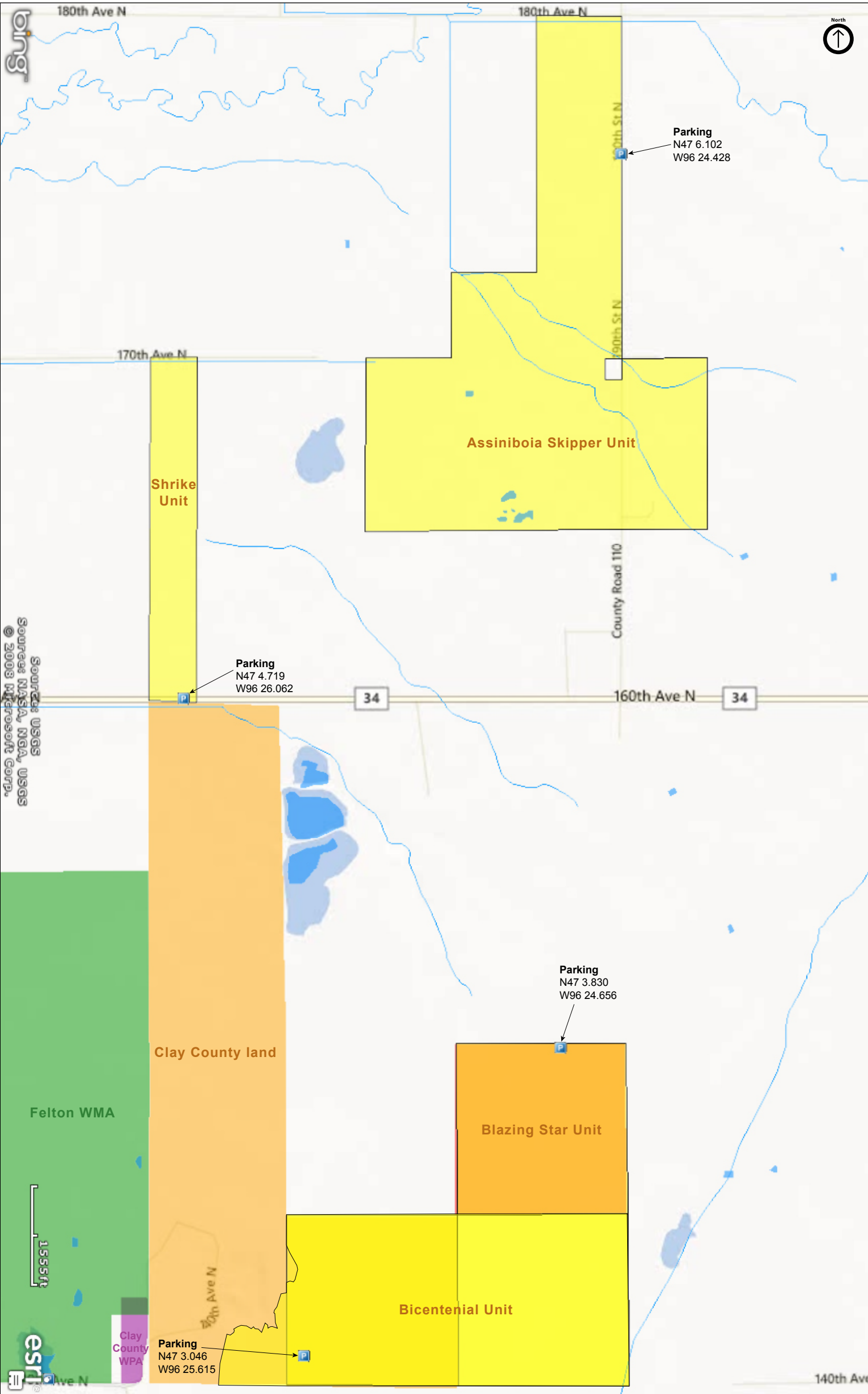

Directions and Notes from Minnesota DNR

1) (Assiniboia Skipper Unit) From Felton 4.5 miles E on Co Hwy 34, then 1.6 miles N on Co Rd 110. Park on E road shoulder.

2) (Shrike Unit) From Felton 3 miles E on Co Hwy 34. Park in pull-off on N, near wood-routed sign.

3) (Bicentennial Unit) From Felton 2 miles S on MN Hwy 9, then 3 miles E on Co Rd 108. Continue on gravel road as it turns N, then E at fork, then in about 1,000 feet, as road turns N to gravel pit, look for field road on E, then E 1500 feet to parking.

This site has no maintained trails or other recreational facilities.
