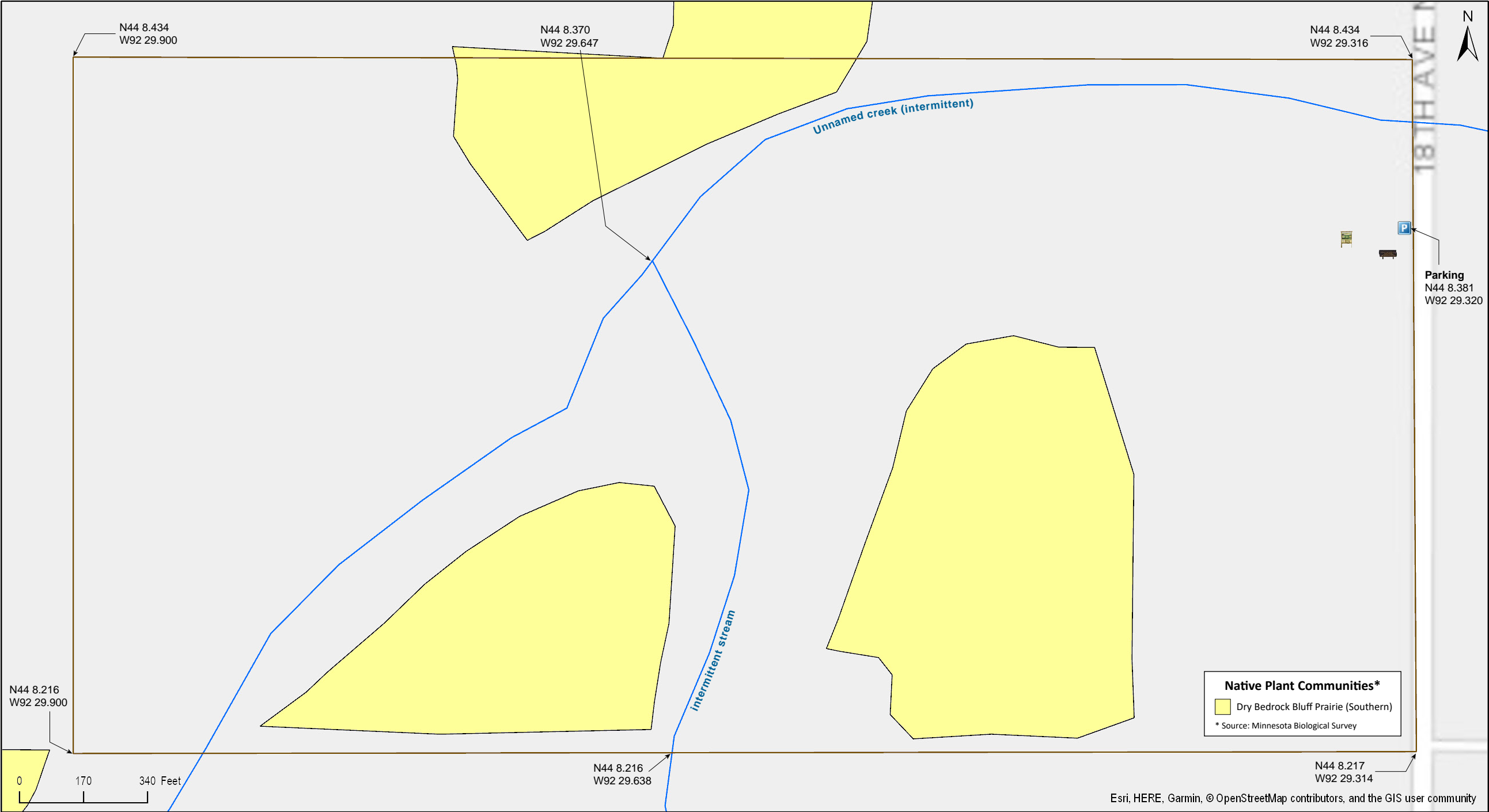

Directions: From Oronoco 1 mile S on US Hwy 52, then 2 miles E on Co Rd 112, then continue S on Co Rd 112 for 0.3 mile. Park in pull-off on W.

Lat/Lon: 44.139678, -92.488654

Old fields will be restored with prairie species from seeds harvested on site. These rare prairie plants distinguish this top-quality prairie.
