

This SNA is easy to miss even if you are looking for it. No wood-routed sign is visible from the road. About one mile north of Sherburne County Road 3 look to left (west) for two SNA boundary markers in an open area. They mark the southeast corner of the site. There is a shared driveway at the northeast corner of the site, and a pull-off on the south side of the shared driveway before the two driveways fork. Park on the pulloff.
