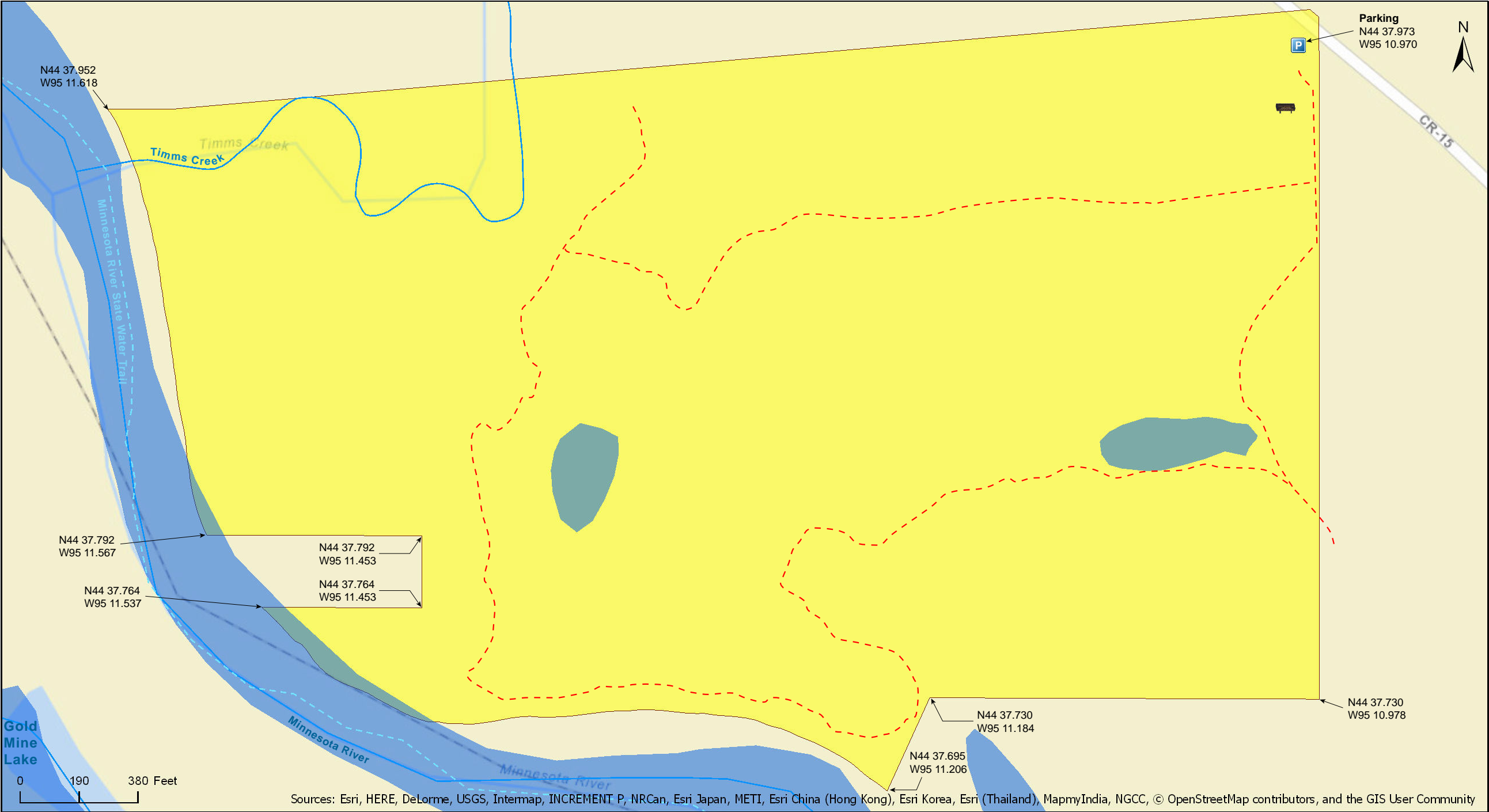

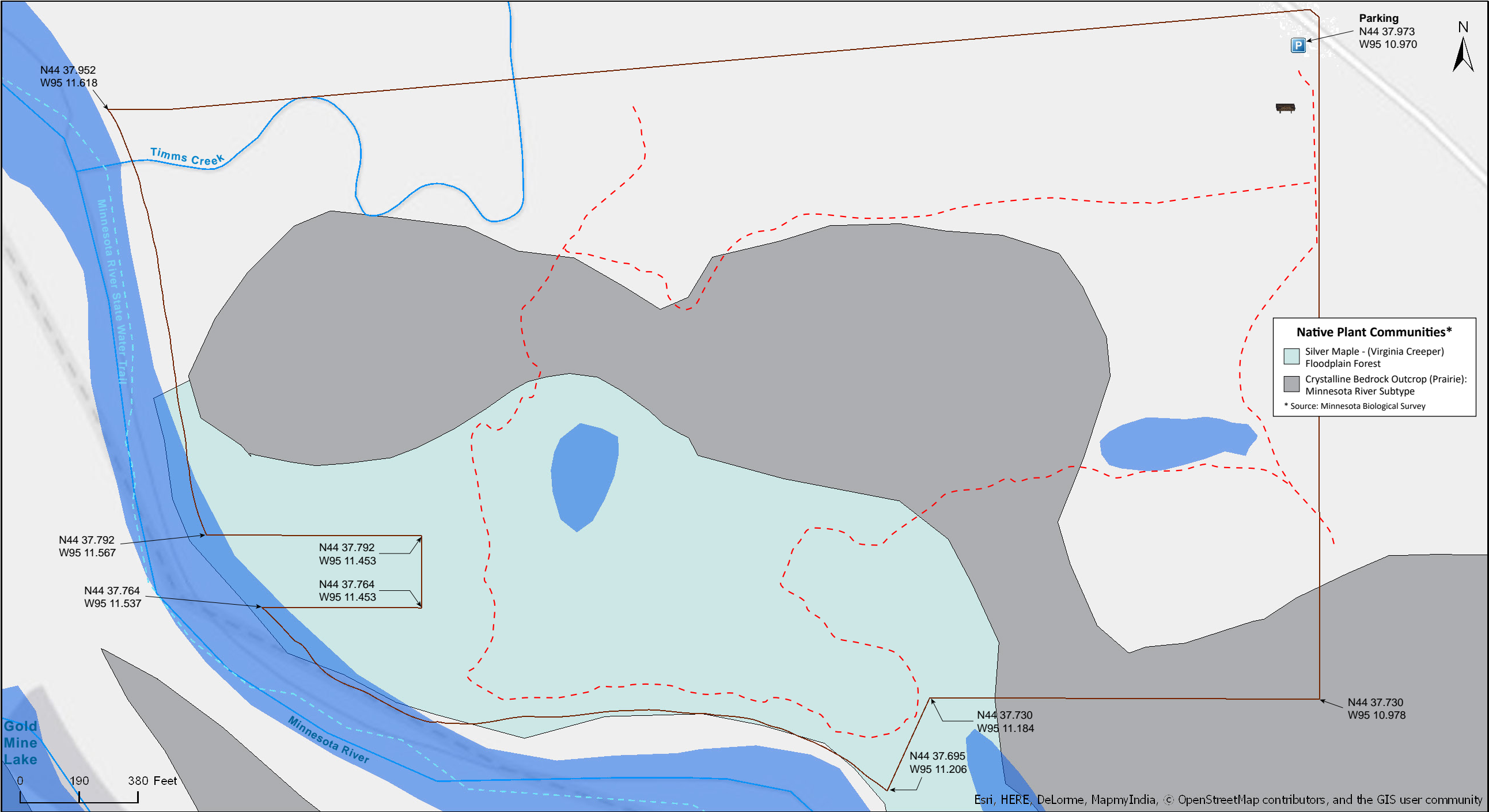

## Notes from Minnesota DNR

**Directions:** From Redwood Falls 1.5 miles W on MN 19, then 7.9 mile N on Co Hwy 17 (Co Hwy 21 after crossing Minnesota River), then W 0.4 miles on Co Rd 15. Park at pull-off and walk SW into site.

**Lat/Lon:** 44.632933, -95.183143

Horseback riding (only on trails and open seasonally May 15- October 15, when conditions allow).

Horse trails final alignments to be developed. Riders will be encouraged to reduce the introduction of invasive species. For example grooming prior to entering the SNA. This site is in an Audubon Important Bird Area.

Rock climbing for sport, including bouldering, is not allowed on Scientific and Natural Areas.
