

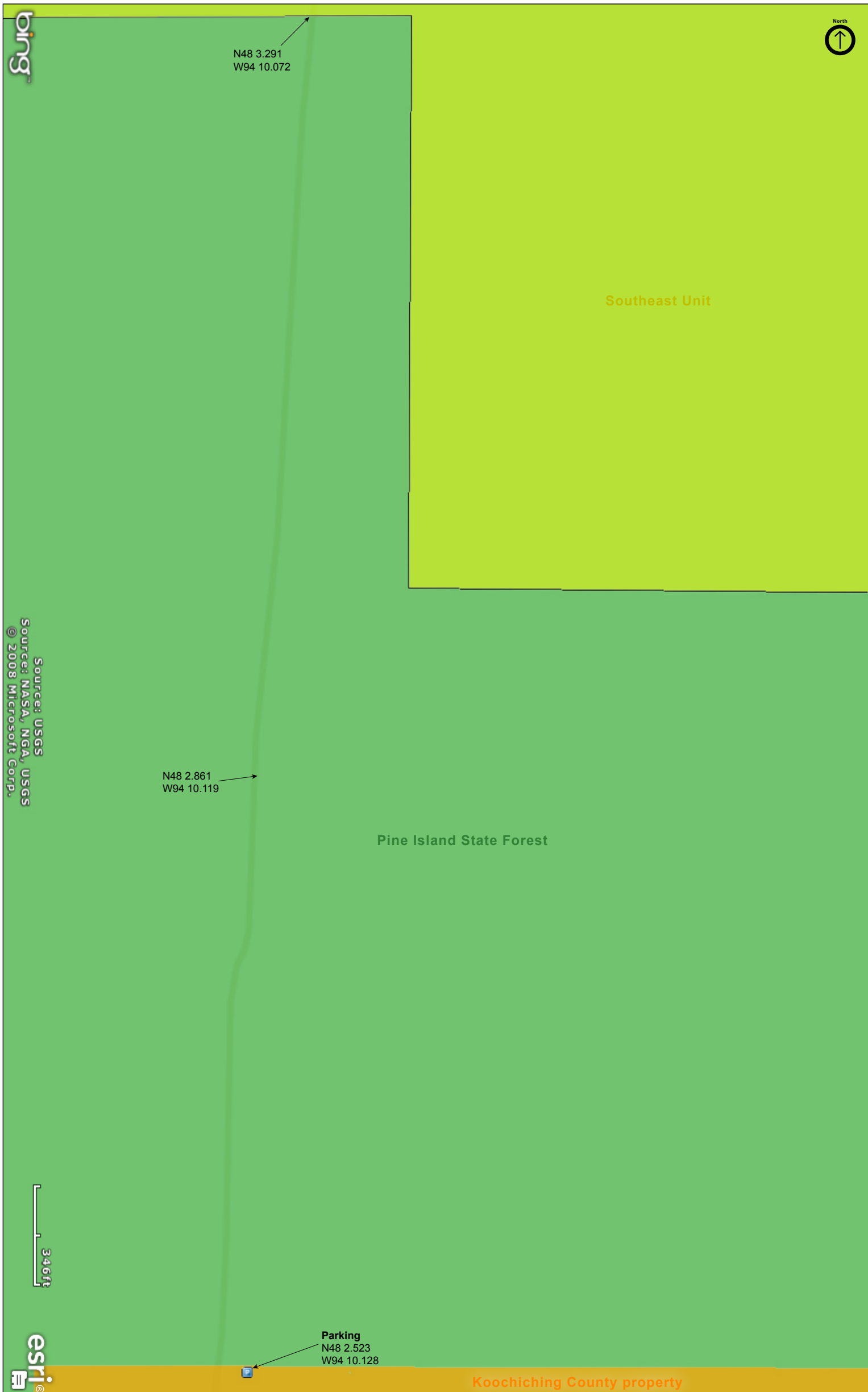

Directions and Notes from Minnesota DNR

From Big Falls 17 miles SW on US Hwy 71, then 3 miles NW on W Gemmel Forest Rd, then 3.25 miles NW on Lost River Forest Rd (last 1.25 miles are minimum maintenance). Park and trek 1 mile N into site. GPS recommended.

A GPS and detailed topographical maps are advised to visit this site.

This site has no maintained trails or other recreational facilities.

This site is within the Pine Island State Forest.
